#### Article 7 Special Education Expendable Trust

Darlene presented an overview of the warrant article.

Elizabeth Brown of Williams Way in Hollis would like to see both the amount raised and the cap raised to higher dollar values due to the costs that can be associated with special education. Darlene asked what levels she would suggest and Elizabeth suggested doubling both.

Tom Solon of Shady Rock Rd in Brookline agreed with Elizabeth that the appropriation be raised to "up to \$100,000" and that the cap should be doubled from \$125,000 to \$250,000.

# Article 8 Catastrophic Aid

Michelle St.John of Orchard Dr. Hollis asked for the distinction between this article and article 7, the special education expendable trust. Darlene explained that this article provides access to state aid while article 7 sets aside local tax funds.



Tom Solon of Shady Rock Rd in Brookline stated that catastrophic aid is state aid for costs above a certain minimum level.

#### Article 9 Transact any other business

There was no public input.

The amendment failed 2-5-0. Brian and Krista voted "yes". Jim, Raul, Darlene, Tom and Lauren voted "no".

The article is recommended 6-1-0. Jim, Brian, Raul, Darlene, Krista, and Tom voted "yes". Lorin voted "no".

#### **Administrative Business**

The Budget Committee members will need to go to the SAU individually to sign the forms related to the warrant articles when they are ready.

Lorin moved that the February 22<sup>nd</sup> meeting be canceled. Jim seconded. Approved 7-0-0. Jim, Brian, Raul, Darlene, Krista, Tom and Lorin voted "yes".
