### **CITIZENS PETITION WARRANT ARTICLE**

- Public Hearing Date – Wednesday, February 20, 2019

Chairman Maguire noted the Public Hearing scheduled for Wednesday, February 20, 2019 on the Citizens Petition Warrant Article.

Superintendent Corey commented the Petition was handed out at the Board's January 10, 2019 meeting, and attached to the minutes of that meeting. It was also included as part of the <u>agenda</u> packet for this meeting.

The Deliberative Session will take place prior to the Public Hearing. At the Deliberative Session (February 4<sup>th</sup>), the legislative body (those voting at the Deliberative Session) will determine the wording of the Warrant Article. The legislative body can amend the wording of the question with respect to the percentage. It can be changed to either a fixed dollar amount or a fixed percentage. The Deliberative Session determines the ultimate number by a simple majority vote.

The Public Hearing scheduled for February 20<sup>th</sup> is a legal requirement. Whatever is decided at the Deliberative Session will be what is presented for the Public Hearing on the 20<sup>th</sup>. The Article cannot be changed at the Public Hearing.

Additionally, were the article (tax cap) to pass, it would be for FY20. At any subsequent meeting, the legislative body can vote, by a simple majority, to override the tax cap and increase or decrease the budget, subject to the 10% limitation. In other words, the tax cap does not limit the voter's authority to increase or decrease the amount in the budget at the Deliberative Session.

Superintendent Corey commented, were the article to pass, moving forward, the Board could determine whether there is the desire to put forward, in addition to the tax cap budget and default budget, a School Board budget (what the Board would propose were there not a tax cap). Other communities have prepared budgets in this fashion having been faced with the question of what the Board would have proposed were the cap not in place.

Superintendent Corey stated his concern with a tax cap to be centered around the many legal mandates the District is required to adhere to, e.g., contracts, special education costs, etc. A 2% increase could be reached very quickly. In this year's budget, the special education cost increases alone would have reached that level and would have forced the District to make cuts to regular education items.

Chairman Maguire questioned, if the article were to pass, if the adopted budget amount would become the baseline for the following year's budget, and was informed it would.

When asked, Superintendent Corey explained, in future years, there could be a Citizen's Petition to repeal the tax cap. Legal counsel will be asked if such a petition could be generated by the Board.
